INDIGENOUS SCHOLARSHIP APPLICATION 2021

The PLC Foundation Indigenous Scholarship is awarded to students who live in the Perth Metropolitan area and would otherwise be unable to attend PLC due to their family's financial circumstances. The PLC Foundation Indigenous Scholarship is offered to successful students commencing PLC in any year from Year 7 to Year 10. The Scholarship covers full tuition fees.

Applicants are required to be a citizen or permanent resident of Australia, residing in Western Australia.

Applicants must demonstrate:

- sound academic achievement;
- a commitment to the community; and
- show participation in co-curricular activities.

The family of eligible applicants must be able to verify that their family's financial situation would mean they would otherwise not be able to attend PLC. Shortlisted applicants will be required to have their financial position assessed by Edstart [edstart.com.au], an evaluator independent of PLC, at no cost.
